

In 2013, the Federal Government deliberately amended the Age Discrimination Act to legally exclude people over the age of 65 from the NDIS. This is age discrimination in its purest form and impacts not only those who are already living with a disability but also those who become disabled after the age of 65.

Right now, people older than 65 who are living with a disability are NOT eligible to apply for the NDIS and many are struggling to survive on just \$52,000 a year from the My Aged Care Scheme.

We've launched the Disability Doesn't Discriminate campaign to raise awareness on this important issue. We're asking Australians to sign our petition and show support for change.
